

## Warm Springs Cabana Club 2010 Swim Season Rules

### General Rules

1. The pool manager and lifeguard have full authority to enforce the following rules and to take any action necessary to protect all attending people and the WSCC facilities and premises.
2. Dues must be paid in full before membership benefits are available.
3. Everyone must check in at the gate before entering the premises.
4. Between Noon and 6PM, a child member, eight (8) or older, may bring 1 non-member guest eight (8) or older unaccompanied by an adult. Both children must have passed a WSCC lifeguard's swimming test. A signed Child's Permission Slip is also required (see rule #5 below). At 6PM, all children under eighteen (18) (members and guests) must be accompanied by an adult or must leave the WSCC premise.
5. A member must accompany his/her guest(s) at all times. If the guest is under eighteen (18), a signed by an adult member and the guest's parent must be presented to the gate attendant before admission. Guest fees do not apply only to anyone over fifty-five (55) or under two (2) and **not** using the pool, hot tub or sauna.
6. Any party or group attendance of ten (10) or more people must be pre-approved by the pool manager or WSCC board. Guest fees and permission slip approval apply to all non-members. The sponsoring member is responsible for additional lifeguard fees if required.
7. Parents are responsible for their children while on WSCC premises.
8. No one under the age of 18 is allowed in the sauna at any time. I.D. must be provided to the MSA before entering the sauna.
9. While the pool is closed, only swim lesson students are allowed in the pool. WSCC insurance requires all others to remain at least two (2) feet from the edge of both pools and spa.
10. No wet bathing suits are allowed in the clubhouse.
11. No smoking is allowed on WSCC premises.
12. No glass, gum or popcorn is allowed in the pool area.
13. No balloons are allowed in the pool area.
14. All members and their guests are responsible for cleaning up after themselves.
15. No running on WSCC premises.
16. Bikes must be parked in the bike rack. Skateboards and skates must be checked at the gate.
17. No dogs allowed on WSCC premises.
18. Showers should only be used before entering or leaving pool premises. No excessive shower use is allowed.
19. Moderate alcoholic consumption is allowed on the premises for anyone over the age of twenty-one (21) at the discretion of the pool manager, WSCC Board members or lifeguard. Proper I.D. must be available. Illicit drugs are prohibited.
20. No member, guest or visitor shall reprimand or harass any WSCC employee or contractor. Any WSCC Board member or pool manager handles any complaints regarding a SWCC employee or contractor.
21. Offensive behavior, vandalism, and general disregard of others enjoyment of the facility will not be tolerated.
22. Cabana Club rules are in place to insure the enjoyment of ALL members. Individuals repeatedly reprimanded may be asked to leave the premises for a period of time, up to and including the remainder of the season.

## **In The Water Rules**

23. WSCC insurance requires that one (1) lifeguard must be present before anyone is allowed to swim.
24. All swimmers who failed the lifeguard's swim test (able to swim unaided from shallow to deep end, without stopping) must remain in the three to four (3 – 4) feet pool area unless being held by an adult.
25. At every fifteen (15) minutes before the hour, there will be an adult swim. Only children three (3) and under held by an adult and adults (18 and older) are allowed in the pool. No children are allowed in the baby pool or the spa during adult swim. WSCC insurance requires all children to remain at least two (2) feet from the edge of both pools and the spa.
26. Anyone with colds, skin diseases, open sores or other communicable diseases cannot enter the pools or spa. All bandages must be removed before entering the pools or spa.
27. No gum food or drink is allowed in the pools or spa.
28. Only children five (5) and under may use the wading pool.
29. Spa capacity may not exceed 11 people. Anyone under sixteen (16) must be accompanied by an adult either in the spa or under the gazebo. Heads of persons must remain above water at all times. No swimming or pool toys allowed in the spa.
30. If required, children must wear swimming diapers when using any pool or spa. Ordinary diapers with plastic pants do not give adequate protection.
31. The lifeguard must approve all pool toys and flotation devices before use. No hard balls are allowed.
32. When the lane line is in the water, members swimming laps have priority. No one is allowed to use the lane line as a flotation device.
33. No cameras are to be used while in the pool.
34. Only one person is allowed on the diving board at a time. No diving until the previous diver has moved away from the diving area. Divers may bounce only once, dive straight out and swim directly to the side. Divers may not perform back flips without lifeguard's permission. Hanging on the diving board, or being under the diving board is not allowed.
35. Three (3) short whistle or siren blasts indicate an emergency situation and everyone must evacuate all pools and spas.
